Out-of-state and upper division business courses: College Algebra (or higher level math) and Microeconomics completed outside of Utah are usually accepted for pre-business requirements without a petition. Students transferring from an institution outside of Utah or who have completed upper division business courses may need to petition their business courses for equivalency. Students are encouraged to contact an academic advisor in Undergraduate Advising Services at (801) 581-7853 if they have questions about out-of-state and/or upper division business courses.

General Education and Bachelor Degree requirements:

Students should discuss general education and bachelor degree requirements with their business advisor as some business courses will count as general education and/or bachelor requirements listed at ugs.utah.edu/gen-ed-reqs. Transfer students who have an associate of arts or associate of science degree, or have completed the general education program at another Utah state-supported college or university are considered to have satisfied the University of Utah's general education requirements.
